


CEZA FACTS AND FIGURES

CAPITAL INVESTMENTS (in billion pesos)






For year 2019, CEZA recorded an increase in capital investment by 8.2% vis-à-vis from the year 2018, accumulating a total investment amounting to P 13.07 billion from P12.625 billion.



DISTRIBUTION OF INVESTMENTS

In terms of share in investments, the biggest contribution came from the real estate segment about 35% amounting to P 4.51 billion, gaming operations at 22% amounting to P 2.86 billion, Integrated gaming support service provider at 14% with an amount of P 1,794.01 million and with **Commercial and Industrial Facilities Operation at 13%** amounting to P 1,657.00.

Distribution of Locators (by type of activity)






Notable increased in the number of locators Fintech Solutions and OVCE to 50 in 2019 from 29 in 2018.

Real Estate segment also increased from 10 in 2018 to 13 in 2019.

DISTRIBUTION OF CEZA ENTERPRISES (by type of activity)




In terms of number of locators. 36% registered from Financial **Technology solutions and OVCE or total of 50 registered** locators, Integrated Resort **Operations/Leisure Facilities Operations registered at** 12% with a total number of locators at 16, Integrated Gaming Support Service Provider at 11% which stood at 15. Real Estate at 9% with 13 locators and Trading and services at 9% with 12 locators.



2019 Annual Revenues (in million pesos)






CEZA earned a total revenue amounting to P 402.22 **million** in 2019.



TOURIST ARRIVALS






Domestic tourists comprised about 76% and 24% for foreign tourists in 2019.

Since March 2018, CNIA recorded an average 10 international flights monthly.







Number of Passengers (Cagayan North International Airport)

The number of ship calls decreased in 2019 vis-à-vis 2018.


Main reason for the decrease was the Port Users started to utilized bigger ships which can accommodate larger cargoes in their transactions.


EMPLOYMENT (Ratio of All Cagayan Local vs All Filipino Employed)



In terms of employment within the CSEZFP, CEZA registered 96% 96% of the workforce of the registered locators were 90% Cagayanos in 2019, an increase from 90% in 2018. 
EMPLOYMENT (Ratio of CEZA-Endorsed vs. Hired)



In year 2018, all endorsed by CEZA were entirely hired by registered locators but it was again dipped in 2019 with the rate of hiring decreased at 52%.

The only group that registered an increases in income was the PASAMOBA which earned P 6.09 in 2018 and P 6.5 million in 2019.

In terms of amount of income, only Palaui Tourist Guides and PASAMOBA incurred an income consistently in million pesos.

PEPA, Palaui Reef Guides, Palaui Catering, Spa and Weaving also recorded significant earnings within two (2) years.
