



MEMORANDUM CIRCULAR NO. 20-003

TO: All Interactive Gaming Licensees/Interactive Gaming Support Service Providers/BPO and Land-Based Casino Operators

SUBJECT: General Community Quarantine for the Management of Coronavirus Disease 2019 (COVID-19) Situation

DATE: 02 June 2020

Consistent with the Memorandum Circular No. 20-002 issued by the undersigned dated 02 June 2020 regarding Resolution No. 41 of the Inter Agency Task Force on Emerging Infectious Diseases (IATF) dated 29 May 2020 in relation to the implementation of General Community Quarantine (GCQ), the Cagayan Economic Zone Authority (CEZA) is reiterating the following instructions regarding the operations of Interactive Gaming Support Service Providers/BPOs and Land-Based Gaming Operators. These instructions will be implemented by operators until 15 June 2020 unless otherwise notified by CEZA.

For Land-based gaming Operations

1. Continued shut down of all land-based casinos.

For BPO Interactive Gaming Operations

2. Interactive gaming operations may continue subject to the following:
 - 2.1. BPOs can supplement their operations with additional staff provided they comply with the most current CEZA and Santa Ana LGU guidelines on General Community Quarantine.
 - 2.2. Supplemental staff should secure a return to work health clearance from a competent health professional of the LGU or DOH as stipulated in the most current CEZA and Santa Ana LGU guidelines on General Community Quarantine.

For Connectivity/Networks Operations

3. Up to 100% of the workforce can return to work, provided all staff secure return to work

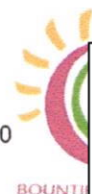

For Other Operations

4. Security guards should be deputized by the company HR to strictly enforce the Santa Ana LGU guidelines on General Community Quarantine.
5. Construction and renovation works of casino areas are allowed provided workers comply with the General Community Quarantine guidelines on construction works provided by Santa Ana LGU.

In addition, please submit to CEZA Santa Ana Office copy furnished LGU Sta. Ana list of employees reporting for work starting June 01, 2020 who are from and outside Santa Ana.
